SCOPE OF WORK

To provide cellular phones and reliable cellular service to ensure safe bus operations and reliable communications, primarily throughout Vermont, the Upper Valley of New Hampshire, and other areas of New England and the United States.

Service area coverage, equipment and service pricing, reliability of service, and equipment, flexibility for expansion, and ease of administration should be provided to us for consideration.

- The service area will encompass the widest network available for State and National coverage with good reception in those areas being of great importance.
- Service in Addison County and the Champlain Valley is of great importance.
- Service in Orange and Windsor County and along the I-89 and I 91 corridors as well as the upper Valley is of great importance.

EOUIPMENT

Minimum Required Equipment

- 22 standard flip phones that have call in and call out capability.
- Service area coverage will be for Addison, Orange, and Windsor Counties.
- Four Smart phones that have calling, email, and text capability.
- Service area coverage will also be primarily Addison, Orange, and Windsor counties.
- Ability to expand our options with similar pricing for equipment.
